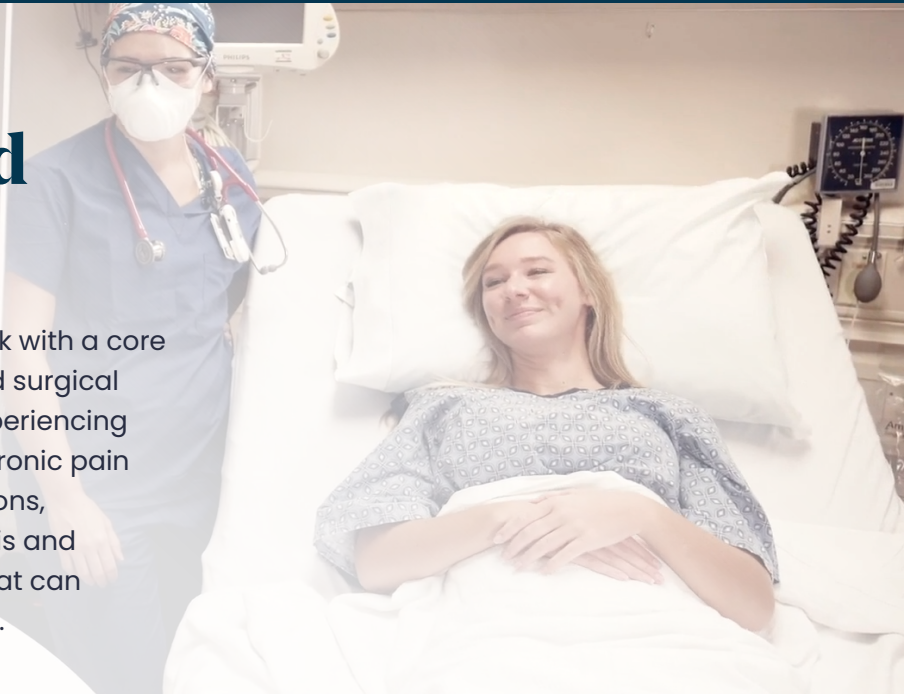
OUR VISION FOR EXCELLENCE
